General Rules and Regulations

1. Exhibits may be brought to the Premium Exhibits Building at the fairgrounds from 4:00 – 7:00 P.M. on Thursday, November 3rd.
2. Entry forms should be turned in with your entry. No pre-registration is necessary. An unlimited number of entries are allowed in each lot, but one family may win only 2 awards per lot.
3. All exhibits must remain in place until Sunday, November 13th, and must be picked up between 10:00 AM and 2:00 PM that same day.
4. Any exhibit not picked up by Noon will become the property of the National Peanut Festival.
5. Department Chairmen will be responsible for checking on your exhibit daily. All exhibits will be UNMANNED.
6. There shall be no soliciting of funds in the exhibit area.
7. Reasonable caution in the safeguarding of all exhibits will be exercised, but the Festival Staff CANNOT assume responsibility for any loss or damage incurred.
8. No exhibitor tickets will be given for the items entered.
9. All baked goods must have at least 50% honey as the sweetener and must be securely wrapped in Saran wrap. Please submit the recipe with all baked goods entered.
10. PLEASE USE NON-RETURNABLE TRAYS FOR BAKED GOODS.
11. Lot 04 (Misc. Hive Products) entries must state what hive products are used on the entry form.
